## **Financial Need Based Assistance**

**Step 1: Fill out Application.** This Assistance requires an evaluation of your family's need;

1. **Financial Analysis Application** (one per family) must be completed. This can be done online at [www.cfslogin.com](http://www.cfslogin.com) or contact your school for this application.

**In addition to this**, we require that you provide us with:

2. **IBE Application.** (One per student) Contact your school for this application, or you can locate this on line at [www.ibescholarships.org](http://www.ibescholarships.org) to submit electronically.
3. A copy of last year's **IRS form 1040**
4. **A letter of explanation** if you believe you have unusual or extenuating circumstances that you would like the Scholarship Committee to consider.

**Step 2: Review by the Scholarship Committee.** They will review your processed application in light of the assistance you qualify for and the amounts available for distribution. The personal information that you are required to provide for application is kept confidential within this committee.

**Step 3: Decision.** IBE's Scholarship Committee begins meeting in April and continues monthly till all funds are dispersed. IBE will inform you of the committee's decision.
